

8 Mistakes People Make When They Are In Debt

2. Not discussing the issues with the creditor: If you have received a warning, then it is important that you do not avoid it. Many people think that it is a good idea to try to sneak away from dealing with their creditor, but it is not. Give them a call and talk to them about your situation.

3. Waiting until the creditor applies to court before you act: People do not realise that if they let it get to this situation that they will not only have to pay the debt but also have to pay all the legal costs which will be many thousands of dollars on top.

4. Becoming hostile or argumentative: The people dealing with your situation are obviously humans and have feelings as well. If you are aggressive and argumentive they are less likely to want to help you and will more than likely give you a hard time and make your situation more difficult.
